# **DECISION**

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 grants the application by Kelsey Rose <u>HAUGH</u> on behalf of the SOUTH WAIKATO DISTRICT COUNCIL SOCIAL CLUB for an on-site Special Licence in respect of premises situated at <u>'SOUTH WAIKATO SPORTS & EVENTS CENTRE'</u>, Mossop Road, Tokoroa subject to conditions.

### **Conditions:**

The licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

Friday 7 June 2024 6.00pm to 9.00pm.

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol;
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard;
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;

- 6. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- 8. No BYO alcohol is to be brought into the event.
