# DEDICATED WATER FILLING STATIONS



### **DEDICATED WATER FILLING STATION**

The South Waikato District Council operates a Dedicated Water Filling Station for bulk supply to mitigate backflow risk and contamination.

Accessing the water network through a smart fire hydrant for a purpose other than firefighting is prohibited.

Contractors wishing to use the Station must apply and once approved, follow the process described in this document.

### Location:

1-59 Croad Place, Tokoroa 3420 (-38° 12' 50.6" 175° 52' 20.9")





### **COMPLIANCE**

Anyone wishing to use a Dedicated Water Filling Station must only do so after applying to and receiving approval from the Council

Approval is contingent upon the user complying with the following:

- Acceptance of current Terms and Conditions
- Possession of physical or digital copy of permit
- Use of only Council-owned metered pipes
- Competency in safe and correct use of hydrant / standpipe.
- No damage imposed on ground near to station
- No excessive load imposed on station
- Any amended condition the council notifies the user of.

### ANY REPAIR COSTS OF DAMAGE ARE RECOVERED FROM USERS

The Council reserves the right to revoke a permit given if a user fails to comply with one or more conditions above.

You are <u>required</u> to notify and request permission from the Water Services Team prior to any use of a Dedicated Water Falling Station hydrant.

The hydrant is available anytime.

### **PROCESS**

# HOW TO ACCESS WATER FROM THE SMART HYDRANT ON CROAD ROAD, TOKOROA

- Unlock the padlock using the key supplied by council
   Open the Managa liderator to image.
- 2. Open the Moneca lid, refer to image below



4. Wait for the lid to pop open (if after a minute the lid should not pop open take the card out, shut the lid, wait a couple of seconds, insert the card again as you did in step 3 shut the lid and lightly press down on the lid).



7. hold down the "+" button as shown in the image below to increase water pressure.When you have reached your desired take hold down the "-" button until the flow has stopped



3. Insert your Bayard Smart Hydrant card, as shown in the image below and close the lid.



- 5. Once the lid is opened connect your hose and fitting to the smart hydrant
- 6. Use a connector to attach your hose to this smart hydrant.



8. Remove your hose and connector, take out your smart hydrant card, place the connector inside the cage next to the smart hydrant, and lock the gate.

# TERMS AND CONDITION OF USE SOUTH WAIKATO DISTRICT WATER FILLING STATIONS



- 1. A permit is required to use any of the designated tanker filling points.
- 2. Submitting an application does not guarantee approval of an application
- 3. Any approval granted is subject to the terms and conditions of the South Waikato District Council Water Supply Bylaw. It is applicant's responsibility to read and understand the bylaw. This is available via our website South Waikato District Council or through our Customer Service Team.
- 4. Contractors should consider the potential for hazards when using the dedicated tanker filling points and be responsible for their own health and safety practices including traffic management to ensure the safety of themselves and the public.
- 5. The supply shall be for the exclusive use of the identified applicant and the Smart Card is not to be made available to other users or be used for private use.
- 6. If permit holders lose their Smart Cards, the cost of a replacement card will be charged to the customer in line with Council fees and charges, which are subject to change on 1 July annually.
- 7. Water may only be drawn from the designated tanker filling points as indicated by the South Waikato District Council. The Council reserves the right to take any of these filling points out of service at any time, as required.
- 8. Water may not be drawn from any other fire hydrant within the district unless specific approval is given. There will be zero tolerance for unauthorised use of fire hydrants. Consequences will include prosecution for water theft and immediate cancellation of rights to draw water from filling stations within the South Waikato District boundaries.
- 9. The permit holder will be liable for the cost of repairing any damage caused by the incorrect operation of our water filling stations.
- 10. The permit holder shall take care not to cause damage to the ground surrounding the filling points. (i.e., use paved road shoulder when pulling in and out and parking as opposed to the industrial fences boundary).
- 11. The permit may be revoked at the discretion of the Council at any time if the use of water is considered excessive or unreasonable. This will be discussed with any permit holders prior to revoking a permit.
- 12. This permit must be renewed every two years, prior to the expiry date.
- 13. A copy of the permit must be always kept in the relevant tanker(s) and be presented to Council staff members upon request.
- 14. Permit holders must immediately report any damage to the water filling stations, including any leaks.
- 15. Any water wastage from excessively leaking hoses and/or fittings may result in a permit being cancelled
- 16. Applicants will be required to pay for their volumetric water usage (per cubic metre) from 1 July 2023. No fees will be charged prior to this date. The rate, once set, will be published in Council's Fees and Charges information on Council's website.
- 17. Failure to comply with the above conditions may result in the permit being revoked.
- 18. The Council reserves the right to amend the conditions of use at any time. All permit holders will be notified of any changes.
